I. Building Permit Application Requirements

amended 5/1/2017

- A. SITE PLAN (2 copies) shall include, but not be limited to, the following:
 - 1. distance from building to all property lines
 - 2. distance from center of road to building (include front setback & road right of way)
 - 3. location of all existing buildings
 - 4. location of septic field & tank or sewer line; sump line; and well
 - 5. building grade in relation to center of road and neighboring structures; grade elevations at corners; floodplain elevations & contours if applicable
 - 6. utility easements & overhead lines
 - 7. general drainage of lot
 - 8. signed & sealed by registered engineer or surveyor
- B. BUILDING PLANS (2 complete sets required) shall comply

with the Michigan Building Code and shall include, but not be limited to, the following:

- 1. foundation plan
- 2. floor plans shall be proper scale and clearly show room sizes
- 3. section cut through fireplace to show construction
- 4. indicate floor and roof framing sizes and spacing
- 5. show building elevations of all sides and dimensions
- 6. indicate correct window sizes and types
- 7. cross section of house showing R-factors of insulation and general construction
- 8. homes with over 3500 square feet of living space require an architect's seal
- C. LEGAL DESCRIPTION or lot number
- D. BUILDER'S LICENSE NUMBER and information required by State of Michigan Act 135 of 1989
- E. SEPTIC PERMIT issued by the Macomb County Environmental Health Department, 43525 Elizabeth Road, Mt. Clemens, 586-469-5236 or TOWNSHIP SEWER TAP PAYMENT & PERMIT
- F. WELL PERMIT issued by the Macomb County Environmental Health Department (see item E. above)
- G. SOIL EROSION PERMIT issued by Macomb County Public Works Department, Permit Department, 21777 Dunham, Clinton Twp., 48036, 586-469-5325 or letter of exemption
- H. APPROACH PERMIT issued by Macomb County Department of Roads Permit Department, 117 South Groesbeck,
 Mt Clemens, 48043 586-463-8671 PRIVATE ROADS DO NOT REQUIRE THIS PERMIT
- I. UNIFORM ENERGY CODE (UEC) CALCULATIONS WORKSHEET is <u>required for all new homes</u> (homes <u>over</u> 3500 square feet of living space <u>also</u> require a heating plan)

D. PLUMBING, ELECTRICAL, AND MECHANICAL PERMITS

Costs vary with size and type of job- a complete fee schedule and applications are available on request.

III. Financial Guarantees

All applications for issuance of building and /or remodeling permit shall be accompanied by a financial guarantee to the Township to assure compliance with all Township ordinances pertaining to construction and occupancy of new or remodeled structures.

SINGLE FAMILY RESIDENTIAL NEW CONSTRUCTION

ALL OTHER CONSTRUCTION AND/OR REMODELING shall be based on the following table:

Financial guarantees may be in the form of either cash or check. Upon full compliance with all Township ordinances pertaining to construction, the balance of such financial guarantee will be refunded to the applicant following the next regular Bruce Township Board meeting.

IV. **Conditional (Temporary) Occupancy**

In the event a conditional (temporary) occupancy is authorized by the building inspector, an additional financial guarantee will be required. (see III. Financial Guarantees)

V. **Inspections**

Bruce Township's inspectors are employed on a part-time basis; therefore, we ask that inspection requests be made a minimum of one day in advance. Inspections for the following business day must be called in not later than 4pm.

Our REGULAR OFFICE HOURS are 8:30am to 4:30pm, Monday through Friday

Messages, questions and inspection requests can be made by leaving a message at the Direct Line on the recorder, fax or e-mail. Inspections for the following day must be scheduled not later than 4pm. (For inspection requests - give information regarding site address, type of inspection, date the inspection is needed: name & phone number of caller; and special instructions regarding entry.)

Permits are granted on the express condition that the CONTRUCTION SHALL, in all respects, CONFORM TO THE ORDINANCES OF BRUCE TOWNSHIP regulating the construction of buildings, and may be revoked at any time upon violation of any of the provisions of these ordinances.

Building, plumbing, electrical and mechanical PERMITS ARE VALID FOR TWO YEARS.

In addition to a building permit, plumbing, electrical, mechanical, fireplace, softener and gas piping, OTHER PERMITS MAY BE REQUIRED. Application for these permits is to be made by the licensed contractor performing the work or the homeowner when the homeowner is doing the work.

VI. Miscellaneous Information (continued)

SPECIAL INSPECTIONS and REINSPECTIONS are not included in the regular permit fee and are to be paid before another inspection will be scheduled.

For ROUGH and FINAL INSPECTIONS, the plumbing, mechanical and electrical work must be approved before the building inspection can be scheduled.

TOILET FACILITIES MUST BE PROVIDED for construction workers throughout the project.

A DUMPSTER MUST BE PROVIDED and the construction site be kept clear of debris throughout the project.

Prior to and during construction, it is required the ADDRESS BE DISPLAYED IN 4" NUMBERS, and made visible from the road. Township Ordinance #172 also requires, prior to occupancy, a PERMANENT ADDRESS POST be located not more than 20 feet from the road right-of-way and not more than 10 feet from the vehicular entrance or drive to the principal building.

A PRELIMINARY HOUSE GRADE & LOCATION CERTIFICATE is required prior to beginning rough carpentry. This must be a certified as-built elevation of the lowest floor (including the basement) completed by a registered land surveyor, engineer or architect.

AN AIR LEAKAGE / BLOWER DOOR test certificate is required before final building inspection.

A FINAL HOUSE GRADE & LOCATION CERTIFICATE is required prior to a final building inspection. This must be a certified as-built elevation certificate showing elevations at the house & the perimeter of the lot.

Prior to a rough building inspection, DOCUMENTATION FOR ENGINEERED TRUSSES and joists must be filed with the building department.

LETTER CONFIRMING TYPE AND R-VALUE OF INSULATION IN ATTIC is required.

If the construction is within the SEWER AND/OR WATER DISTRICT OF THE TOWNSHIP, a sewer and water tap permit is required. These permits can be issued only to a licensed contractor registered with the Township.
