

**RESOLUTION APPROVING EMERGENCY FIRE AND  
AMBULANCE SERVICE USAGE FEES**

Minutes of a regular meeting of the Township Board of the Township of Bruce, County of Macomb, Michigan held in the Township municipal offices in said Township on July 28, 2022 at 3:30 P.M., Eastern Standard Time.

The following preamble and resolution were offered by Member Kraft and supported by Member DiGiorgio.

**WHEREAS**, Bruce Township has previously adopted Ordinance No. 182, being the Emergency Fire and Ambulance Service Fee Ordinance, on February 16, 2008; and

**WHEREAS**, Ordinance No. 182 provides for the reimbursement and collection of fees charged by Bruce Township for costs incurred by the Township in providing emergency fire and ambulance service to residents and non-residents within the Township; and

**WHEREAS**, it is necessary to increase the emergency fire and ambulance service usage fees charged by the Township for providing emergency fire and ambulance services.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE TOWNSHIP OF BRUCE, MACOMB COUNTY, MICHIGAN:**

1. The emergency ambulance and fire service usage fees are hereby amended as follows:

ALS Emergency	\$900.00
ALS II Emergency	\$1,200.00

ALS Non-Emergency	\$725.00
BLS Emergency	\$750.00
BLS Non-Emergency	\$500.00
Mileage	\$18.00
Oxygen and Supplies	\$50.00
Defibrillator	\$50.00
Extrication	\$500.00
Wait Time	\$70.00
Restocking Fee	\$20.00

2. The rates established by this Resolution shall be effective August 28, 2022.
